

Dimensional drawing in mm



Cautions and warnings

- Surge arresters may become hot in the event of longer periods of current stress (danger of burning).
- Surge arresters must not be operated directly in power supply networks.

- Surge arresters may be used only within their specified values. In case of overload, the lead contacts may fail or the component may be destroyed.
