






Figure 1. Typical Forward Voltage Forward Current vs. Various Temperatures




Figure 2. Diode Capacitance vs. Reverse Voltage V_{R}





Figure 3. Typical Variation of Reverse Current vs. Various Temperatures





Package Dimensions in millimeters (inches): SOT23


