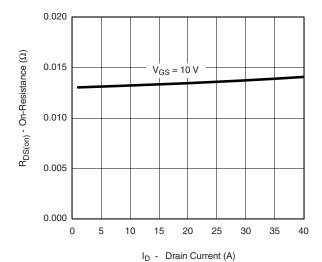

On-Resistance vs. Drain Current

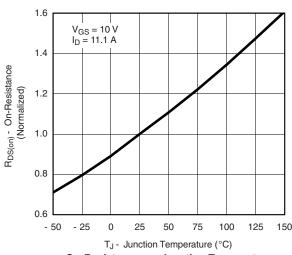




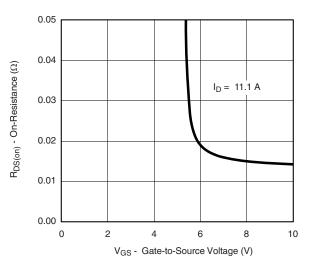

On-Resistance vs. Junction Temperature



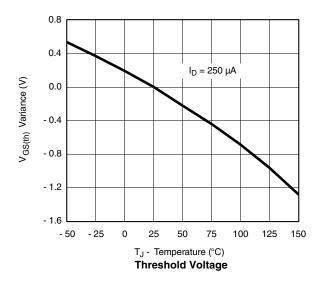
On-Resistance vs. Gate-to-Source Voltage

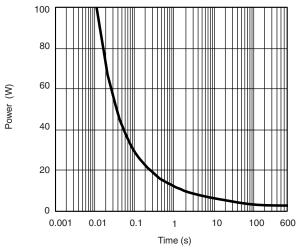

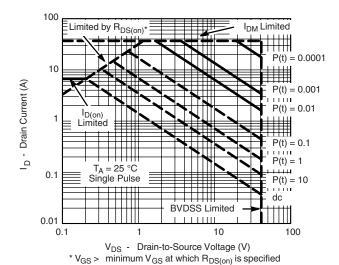

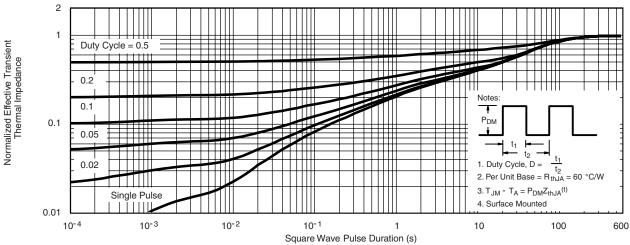




Single Pulse Power



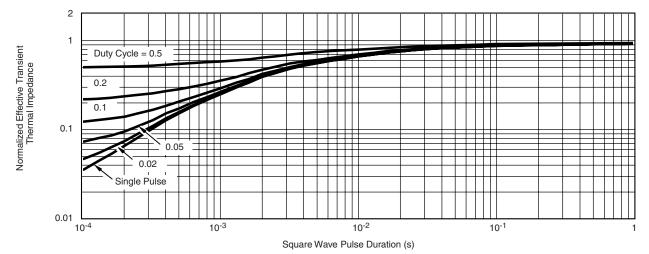
Safe Operating Area, Junction-to-Ambient
