








Fig. 1 - Forward Current Derating Curves




Fig. 2 - Forward Power Loss Characteristics




Fig. 3 - Maximum Non-repetitive Peak Forward Surge Current




Fig. 4 - Typical Instantaneous Forward Characteristics




Fig. 5 - Typical Reverse Characteristics




Fig. 7 - Typical Transient Thermal Impedance





Fig. 6 - Typical Junction Capacitance
