


Fig. 1 - Forward Current Derating Curve




Fig. 2 - Max. Non-Repetitive Peak Forward Surge Current



Fig. 3 - Typical Instantaneous Forward Characteristics






Fig. 4 - Typical Reverse Characteristics

#### **Mounting Pad Layout**






Fig. 5 - Typical Junction Capacitance




Fig. 6 - Typical Transient Thermal Impedance
